Boarding Consent Form

Our boarding facility is open Monday-Friday from 8:30 AM to 5 PM and Saturday from 9:00 AM until noon. **Due to limited staffing during lunch hours, we discourage drop-off or pick-up between the hours of 12 PM to 2 PM.** Our boarding rates are as follows: For dogs up to 30 pounds, we offer cage kennels for **\$19.80**, our indoor-outdoor runs are **\$22.70**. For cats, we offer condos for **\$17.05**. Prices are per pet, per night. For pets with special medical needs, we will administer oral or topical medications for **\$1.25** per occurrence or **\$2.25** per injection per day. Please supply your own needles, insulin, etc.

1) In order to maintain a disease-free environment, we require all pets to be current on vaccines. If Crater Animal Clinic did not administer vaccines, proof of current vaccinations by your regular veterinarian must be presented at the time of drop-off. Vaccines must be given according to manufacturer label.

2) Our vaccination requirements are:

Dogs: **Rabies, Bordetella, Leptospirosis, Distemper, Parainfluenza, Adenovirus, Parvovirus, and Canine Influenza Vaccine.**

Cats: **Leukemia, Panleukopenia, Rhinotracheitis, Calicivirus, Chlamydia and Rabies.**

All booster vaccines must be given at least one week prior to boarding at Crater Animal Clinic. If you have questions about your pet's vaccinations we encourage you to call us at 541-779-0951 to schedule an appointment. ***If you present your pet for boarding with overdue vaccines or no proof of vaccines, we will not be able to provide accommodations for your pet.***

3) We have a flea and tick free environment here at Crater Animal Clinic. To maintain this environment we require current flea and tick control (according to manufacturer label) when boarding. ***If your pet is not currently on flea and tick control we will apply a topical preventative for our current fee.***

In case of emergency, we reserve the right to treat your pet at our discretion should we be unable to contact you. A deposit may be required for reservations during highly requested times. We are not responsible for items left with your pet.
